Pet Puppy Purchase Agreement

Under the terms of this contract, the undersigned parties agree to the following conditions in regards to the sale of this pet puppy described below:

Cindi Williams of Wyndance Golden Retrievers, referred to hereafter as “Breeder” provides the following:

That both the Sire and Dam have been certified free of hereditary hip and elbow dysplasia. Also, both have had their eyes certified clear of cataracts by board certified veterinary ophthalmologists through the Canine Eye Registry Foundation (CERF), and their hearts have been certified to be free from sub-aortic stenosis (SAS) by board certified veterinary cardiologists. Copies of these clearances are provided.

That as of the signature date of this contract, both Sire and Dam have NOT been affected by cancer, epilepsy or allergic conditions to normal environmental stimuli. The preceding conditions are thought to be hereditary in nature, although at present, there is no certification procedure for clearances.

That as of the signature date of this contract, both Sire and Dam exhibit sound, even temperaments with no indication of aggressive tendencies or excessive shyness.

As indicated above, the Breeder has exercised every practice known by ethical breeders at this time to produce sound, healthy Golden Retrievers. A 24-month health guarantee is offered on said puppy regarding genetic defects.

That the litter will have been wormed as necessary and will have had their first “puppy” vaccination. These records will be provided when the puppy is released to the Buyer.

agree(s) as follows:

1. That the purchase price will be _____ and that this puppy is not being offered on a co-ownership basis. A deposit of 400.00 (USD) **WAS / WAS NOT** received by the Breeder. Any balance is due on or before the puppy reaches 6 weeks of age or, with prior agreement between the Breeder and the Buyer, before said puppy is released to the Buyer at 8-10 weeks of age. We ask that the balance be made by Cashier's Check made out to Cynthia L Williams.
2. That the puppy is sold to the Buyer(s) in the good faith that it will NOT be bred. The puppy must be spayed/neutered at the appropriate age (males not less than fourteen months - females not less than eight months). **Registration papers will not be delivered to the Buyer until proof of spay/neuter is provided.**
3. That the Buyer agrees to take the above mentioned puppy to his/her personal veterinarian, along with a stool sample, within five (5) business days of taking possession to verify that the puppy is in good, sound health. If the veterinarian finds an unhealthy condition, said puppy may be returned to the Breeder within three (3) days of above mentioned vet visit for a replacement with a remaining littermate, if available; or another puppy of comparable value from a future breeding, if available; or a full refund of the purchase price.
4. That the puppy is to receive proper veterinary care and a proper vaccination schedule for the duration of its life.
5. That the puppy is not allowed to jump up or down from places higher than its shoulder, or made to jog/run unnaturally (as in running next to a bike) before 2 years of age. These conditions have been shown to bring about joint damage in growing puppies when their tender joints are most susceptible.
6. That the Buyer agrees never to tie or chain the puppy up or allow the puppy to roam unsupervised; to protect the puppy from injury, illness, and theft and to provide a safe, fenced enclosure. In the event of the puppy's/dog's death, the Buyer must notify the Breeder within 36 hours.
7. That the Buyer agrees to provide high-quality food (Breeder's recommendations) and to maintain the puppy at a weight appropriate to its size and age. The Buyer agrees that plenty of fresh water and shade will also be provided.
8. That the Buyer will provide the necessary training, grooming and socialization. Puppy Socialization at your nearest dog training facility is highly recommended. The Breeder agrees to reimburse the Buyer up to \$200 for putting an AKC Canine Good Citizen (CGC) certificate on the puppy within 24 months of purchase.
9. That the Buyer agrees NEVER to sell/give/trade/transfer this puppy to any large commercial breeding establishment, any agent, any wholesaler, or any person(s) residing in this country or another country without first contacting the Breeder.
10. That in the event, at any future time, the Buyer cannot keep this puppy, the Buyer must first contact the Breeder. The Breeder has the first right of refusal. If the Buyer has a good home lined up, the Buyer will notify the Breeder BEFORE the puppy is placed in the new home. The new home must be a pet home and the puppy/dog must be spayed/neutered at the (original) Buyers expense before being placed in the new home. A copy of the spay/neuter certificate will be provided to the Breeder. The new home will be expected to provide high-quality food, water, shade, vet care, grooming, training, and a fenced yard so that the puppy is continually well cared for. Buyer may provide the new owner with a copy of this contract for guidance.

10. The Breeder's kennel name of "Wyndance" will be used as the first word in this puppy's AKC registered name followed by the theme name (if applicable). You are welcome to choose any call name of your liking.

11. If the Breeder witnesses or suspects any neglect and/or abuse, the Breeder will take immediate possession of the puppy and the Buyer will sign off on the AKC registration papers. The Breeder will be responsible for the AKC transfer fees.

12. That any additional terms or conditions are identified on a separate rider to this contract. **YES / NO**
